# **Investment Objective**

The First Foundation Total Return Fund seeks maximum total return (total return includes both income and capital appreciation).

# **Investment Strategy**

The First Foundation Total Return Fund invests primarily in a combination of U.S. and foreign equity and debt securities. The portfolio managers have the flexibility to invest in both large and smaller capitalization companies, and listed companies that may fall outside of traditional equity category classification. With a high-conviction approach, the managers carefully select a limited number of positions, focusing on investments that have the potential for long-term capital appreciation.





- <sup>4</sup> Average Price to Cash Flow: Price to Cash Flow ratio is defined as a stock's capitalization divided by its cash flow.
- <sup>5</sup> Average Price to Sales: Price to Sales ratio is defined as a stock's capitalization divided by its sales.
- <sup>6</sup> **Average Price to Earnings:** The Price to Earnings ratio compares a company's share price to its per-share earnings.
- <sup>7</sup> **Average Price to Book Value:** Price to Book Value ratio is defined as a stock's capitalization divided by its book value.

Securities Market Risk. The value of the securities may go up or down, sometimes rapidly or unpredictably, due to factors affecting particular companies or the securities market generally. A general downturn in the securities market may cause multiple asset classes to decline in value simultaneously, although equity securities generally have greater price volatility than fixed income securities. Growth Investing Risk. Credit Risk. The risk that the Fund could lose money if the issuer or guarantor of a fixed income security, or the counterparty of a derivatives contract or repurchase agreement, is unable or unwilling (or is perceived to be unable or unwilling) to make a timely payment of principal and/or interest, or to otherwise honor its obligations. Interest Rate Risk. The risk that fixed income securities will decline in value because of changes in interest rates. A fund with a longer average portfolio duration will be more sensitive to changes in interest rates than a fund with a shorter average portfolio duration. Derivatives Risk. The risk that an investment in derivatives may not correlate completely to the performance of underlying securities and may be volatile, and may result in a loss greater than the principal amount invested.
